May 2025 Report

Conference Report: We came back with the list of new .gov website do's and don'ts. It was recommended to keep the old site under our control, which I planned on doing anyway or turning it into an unofficial community website. On the .gov site, you are not allowed to have information that is not explicitly connected to the Town or a governmental agency. I have links to the historical society, SPCA, Alumni Association, Lifelong, all the cemeteries, Groton Community Council, Human Service Coalition and others that will need to be removed. They can remain on the .org site...This would cost us less than \$240 a year to maintain.

The cheapest vendor I can find just for DNS hosting is \$348 a year- (we used to pay \$18 a year). DNS is like the "address" of your website as seen by the internet and you have to pay to have that protected or host it yourself. I have a meeting with a website vendor tomorrow.

Updates to Website- Tompkins County Road work maps, and information about Tompkins County transportation "scout" which helps people find different avenues of transportation. Posters are also hung up in the office.

Court Record disposition is on hold. As it turns out, court records are only supposed to be handled by court employees. There are grants to assist with this according to the 6th Judicial district justice. Kathy will see what she can find as he didn't exactly point to where those grants are.

Tax Collectors conference is coming up in June and we will need a resolution to approve Denise and I attend the NY State Tax Collector's and Receivers Conference in Lake George June 8-11th. (Room, meals and registration for both of us without mileage \$ 1,086.20)
